RTO / DTO subsequently to the vehicle sold by us, after receiving all the relevant papers such as Application form No. 30 duly signed by the purchaser / applicant containing the chassis print accompanied by the documents such as Sale letter, Proof of residence, Insurance Cover, Form No. 22 and other prescribed forms issued by the Manufacturer/dealer including road certificate, Pollution Certificate etc. and the Treasury Chalan/Receipt of the Registration fee, HPA fee and Motor Vehicle Tax of India under respective head shall be delivered on the next following day positively to the concerned RTO / Addl. RTO / DTO in whose jurisdiction our purchaser resides or intends to get his vehicle registration for registration number which has been issued to the purchaser.

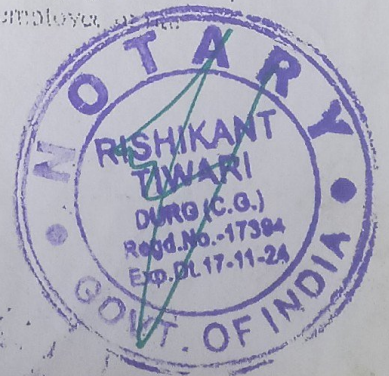
